

Apartment Association of Greater Memphis Statement of Privacy

The Apartment Association of Greater Memphis (AAGM) is committed to protecting your privacy. This Statement of Privacy applies to the AAGM Web site and governs data collection and usage at all AAGM sites and services; it does not apply to other online or offline sites, products or services. Please read the AAGM Statement of Privacy. AAGM is a general audience web site, intended for users of all ages. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.

Collection of your Personal Information

As an E-commerce Web site, AAGM collects personal information, such as your e-mail address, name, home or work address or telephone number. Information collected by AAGM is used solely for the purpose of billing and shipping your online purchases. AAGM does not collect any information about your computer hardware and software.

Use of your Personal Information

AAGM and its operational service partners collect and use your personal information to process product orders and deliver the products requested. It is possible that AAGM may also use personal information to inform you of other products or services available from AAGM and its affiliates. AAGM may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

AAGM does not sell, rent or lease its customer lists to third parties. AAGM may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your personal information (e-mail, name, address, telephone number) is not transferred to the third party.

We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

AAGM does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

AAGM may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on AAGM or the site; (b) protect and defend the rights or property of AAGM, including its Web site; or (c) act under exigent circumstances to protect the personal safety of users of AAGM or the public.

Personal information collected on this site may be stored and processed in the United States or any other country in which AAGM or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country.

AAGM abides by the safe harbor framework as set forth by the U.S. Department of Commerce regarding the collection, use, and retention of data from the European Union.
